Catalog Description:

CSE 3442. EMBEDDED SYSTEMS I. 4 Hours.

Design of microcomputer based systems: microcomputer programming, component and system architectures, memory interfacing, parallel and serial input/output (I/O) interfacing, analog to digital (A/D) and digital to analog (D/A) conversion, and typical applications. Prerequisite: C or better in each of the following: CSE 2100 and CSE 2441.

Tests:

- Calculators, rulers, pencils, pens, books, and notes will be allowed during tests.

Cost:

No textbook will be required. Parts required for the project will generally be less than \$25 per team.

Projects:

- The project will consist of hardware construction and firmware development and it is expected that it will take approximately 60 hours to complete.
- Projects will consist of teams of 1 or 2 students.
- Projects will be defended on the last class day during class hours with interim deadlines for hardware construction and some software milestones.

Attendance Policy:

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Final Review Week:

this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.
