**Catalog Description:**

CSE 4342. EMBEDDED SYSTEMS II. 3 Hours.

Advanced course in design of microcomputer-based systems. Emphasis is on the application of state-of-the-art microprocessors, microcomputers, and other LSI and VLSI components to real-time, interactive, and online problems. Prerequisite: Admitted into an Engineering Professional Program. C or better in each of the following: CSE 3442 and CSE 3313 (or con-currently).

- Proficiency in C programming
- Differences between Harvard and von Neuman architectures
- Differences of microcontroller and microprocessor architectures
- Knowledge of ARM7 family microcontroller architectures.
- Study of microcontroller peripherals including timers, PWM, interrupts, GPIO ports, and ADCs
- Determining microcontroller memory, speed, and capabilities to solve a task
- Measurement and instrumentation applications
- Digital filtering applications
- Device control: Motors, servos, relays, heavy AC and DC loads
- Real-time control applications
- Simple Ethernet stack creation and simple network applications

**Tests:**

**Cost:**

No textbook will be required. Parts required for the project will generally be less than \$25 per team.

**Projects:**

- The project will consist of hardware construction and firmware development and it is expected that it will take approximately 60 hours to complete.
- Projects will consist of teams of 1 or 2 students.
- Projects will be defended on the last class day during class hours with interim deadlines for hardware construction and some software milestones.

**Attendance Policy:**

At The University of Texas at Arlington, taking attendance is not required but attendance is a critical indicator in student success. Specifically, when assigning a student a grade of F, faculty report the last date a student attended their class based on evidence such as a test, participation in a class project or presentation, or an engagement online via Blackboard. This date is reported to the Department of Education for federal financial aid recipients.

Students may drop or swap (adding and dropping a class concurrently) classes through self-service in MyMav from the beginning of the registration period through the late registration period. After the late registration period, students must see their academic advisor to drop a class or withdraw. Undeclared students must see an advisor in the University Advising Center. Drops can continue through a point two-thirds of the way through the term or session. It is the student's responsibility to officially withdraw if they do not plan to attend after registering. **Student Feedback Survey:**

At the end of each term, students enrolled in face-to-face and online classes categorized as "lecture," "seminar," or "laboratory" are directed to complete an online Student Feedback Survey (SFS). **Final Review Week:**

For semester-long courses, a period of five class days prior to the first day of final examinations in the long sessions shall be designated as Final Review Week. The purpose of this week is to allow students sufficient time to prepare for final examinations. During this week, there shall be no scheduled activities such as required field trips or performances; and no instructor shall assign any themes, research problems or exercises of similar scope that have a completion date during or following this week unless specified in the class syllabus. During Final Review Week, an instructor shall not give any examinations constituting 10% or more of the final grade, except makeup tests and laboratory examinations. In addition, no instructor shall give any portion of the final examination during Final Review Week. During

this week, classes are held as scheduled. In addition, instructors are not required to limit content to topics that have been previously covered; they may introduce new concepts as appropriate.

**Emergency Exit Procedures:**

Should we experience an emergency event that requires us to vacate the building, students should exit the room and move toward the nearest exit.
